#### **TERMS AND CONDITIONS**

Colbert County E-911 is hereafter referred to as "911".

1. Proposal offer expiration

Enter the expiration date of your proposal offer on the official proposal provided. A minimum period of 30 days from the closing date is requested. 911 shall have 60 days to accept the proposal if a minimum period is not stated.

2. Insurance

The contractor shall procure and maintain for the duration of the contract, at his/her own cost and expense insurance against claims of injuries to persons or damages to property including contractual liability which, may arise in connection with the performance of the work performed by the contractor, his agents, representatives, employees or subcontractors under the contract. The insurance carrier(s) must be licensed to conduct business in the State of Alabama. The insurance will be evidenced by an original Certificate of Insurance included with the bid. The certificate shall include wording which states 911 will be notified thirty (30) days prior to cancellation of the coverage or a major change in the coverage provided 911 shall be held harmless for any injuries, claims or judgments against the contractor. Certificates for liability coverages shall name 911 as an additional insured. Coverages required are:

Workers' compensation: a certificate shall be provided which indicates the contractor provides workers' compensation coverage in compliance with the state laws of Alabama.

General liability and property damage coverage shall be for all operations under the proposal for at least \$100,000.00 for one person and \$300,000.00 for each occurrence for bodily injury or death; and for property damage at least \$100,000.00 for each occurrence, plus coverage for any equipment being moved.

If not already on file for the current policy year, the vendor shall include an original copy of the Certificate of Insurance with the bid response.

3. E-Verify Participation

In order for the proposal to be awarded, the business entity "shall not knowingly employ, hire for employment, or continue to employ an unauthorized alien and shall attest to such, by sworn affidavit signed before a notary." Additionally, the business entity "shall provide documentation establishing that it is enrolled in the E-Verify program" and that during the contract period, it "shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations."

- Demolition of approximately 40 linear feet of wood stud wall
- Construct and finish with sheetrock approximately 15 linear feet of wood stud wall
- Install approximately 8 linear feet of cabinetry and counter-top, to include a sink and minimal plumbing
- Lower existing drop-ceiling to match other area of existing drop-ceiling.
- Install carpet-tile flooring in approximately 1000 square feet of space
- Move and install electrical to appropriate specifications
